Closing date for club nominations: 23rd January 2019

Shortlist announced: mid-February 2019

Winners announced at the NCCA Ceremony & Dinner: **Saturday 23rd March 2019**

Taking place alongside the Practical Classics Classic Car & Restoration Show, with Discovery: 22<sup>nd</sup> – 24<sup>th</sup> March

## **National Car Club Award Shortlisted entrants will receive:**

- ❖ TWO guest invitations for official use by the Club Secretariat to attend the Awards Dinner and Ceremony on Saturday 23<sup>rd</sup> March 2019. (Up to a maximum of SIX guest invitations per club if shortlisted for multiple awards).
- ❖ NCCA 'Shortlisted' logo / marque in high res format for use in marketing and publicity for the following 12 months.

## **In addition, National Car Club Award Winners will receive:**

- ❖ An award presented on the night.
- ❖ Photo opportunity with the Award's host and fellow NCCA winners on the night.
- ❖ Namecheck in the dedicated NCCA 2019 press release issued after the ceremony and distributed to all key motor vehicle press.
- ❖ NCCA 'Winner' logo / marque in high res format for use in marketing and publicity for the following 12 months.
- ❖ Table topper certificate.

## **In addition, Highly Commended recipients will receive:**

- ❖ Highly Commended acknowledgement by the Award's Host on the night.
- ❖ Namecheck in the dedicated NCCA 2019 press release issued after the ceremony and distributed to all key motor vehicle press.
- ❖ NCCA 'Highly Commended' logo / marque in high res format for use in marketing and publicity for the following 12 months.

#### Who can nominate:

- Club organisations and individuals may nominate themselves. Please ensure that you have the necessary authority from your Car Club's relevant official before you submit your entry.
- Club members may nominate provided they have gained consent from the nominated Car Club's secretariat or relevant official.
- Third Parties may nominate providing they have gained consent from the nominated Car Club's secretariat or relevant official.
- Joint entries from Car Clubs are welcome where appropriate, but a lead proposer must submit a single nomination with the prior agreement of all parties.

#### Nomination Submission:

- Entries will only be accepted when submitted using the official NCCA nomination online forms.
- Car Clubs may be entered into as many different awards as they wish.
- Only one nomination per car club per award should be submitted.
- When submitting nominations for multiple awards, ensure each nomination is specifically tailored to the relevant award and each separate nomination form completed in full.
- Examples of work, projects undertaken and information cited within Classic Car Club Category award nominations should be based on club activities occurring between January 2018 and January 2019. A longer time frame may be referenced for Devoted Member Category award nominations, but with specific reference to their activities during the last 12 months.
- Please note the maximum word count for each question and compose your answers accordingly, avoiding duplication of copy.
- Please complete all sections on the nomination forms in full. Include any reference links or upload any additional supporting documentation at the time of submission.
- Remember to post magazine examples promptly to arrive before the submission deadline.
- Provide a copy of your club's logo / photograph of the nominated individual in high resolution for use on NCCA collateral and promotion. You can either upload a JPG, JPEG, GIF or PNG file where requested in the online nomination form (max 16MB); or email EPS or TIFF files to [alison@inovent.co.uk](mailto:alison@inovent.co.uk) before the submission deadline.
- All nominations will be acknowledged within 21 days of receipt.
- Incomplete nomination forms will be disregarded.
- Nominations close at 11.59pm on Wednesday 23<sup>rd</sup> January 2019. Entries submitted after this date will not be accepted.

#### Confidentiality:

- The information contained in all nominations will remain confidential to National Car Club Awards and the judging panel.
- Details of entries will not be shared with any third parties without the express consent of the entrant.
- Entrants are expected to protect those aspects of their business that may be patentable, confidential or covered by intellectual property and copyright laws.

Judging:

- Nominations will be judged by a carefully selected panel of industry experts. Please refer to the Judges page on the website to find out more about the National Car Club Award 2019 Judges.
- A shortlist of club entrants for each award will be published in mid-February. All companies and individuals who have entered will be advised of the shortlist at this time.
- The Judges reserve the right not to issue a shortlist or make an award for a particular category if, in their view, none of the entries submitted met the required standard and criteria set.
- The Judges may move nominations from one award to another if they believe that it is appropriate to do so.
- The Judges' decision is final and no correspondence will be entered into. The National Car Club Awards 2019 Judges reserve the right to withdraw any entry or award should it later be discovered that the entry included false information.
- The winner of each award will be announced at the National Car Club Awards on Saturday 23rd March 2019. Highly commended acknowledgements may also be made in any award, at the discretion of the Judges.

Publicity:

- It is a condition of entry that entrants will co-operate with the NCCA, its sponsors and the media.
- NCCA reserves the right to publicise the shortlist and results of the competition, and to name-check shortlisted, winning and highly commended entries in press releases, website, on social media and across other media channels.
- NCCA 2019 shortlisted clubs, winners & those highly commended will be required to participate in pre and post-awards publicity if requested.
- NCCA 2019 shortlisted clubs, winners & those highly commended may refer to the awards in their own publicity material together with the relevant logo / marque supplied.
